Collection, Use, Disclosure, Choice

Registration is not required for you to peruse our site. If you are a visitor, we do not collect any personal information about you, except to the limited extent through the use of cookies, which are described below. However, there may be circumstances in which you choose to register for ongoing updates from WhizAnts Pty Ltd. Information collected at registration is protected using industry-standard encryption technology as it is sent over the Internet.

In some cases, WhizAnts Pty Ltd may contact registrants to invite them to special events, provide them with information about our services, publications and products, or for other marketing purposes.

You may choose to register for:

1. **Email Alerts**
WhizAnts Pty Ltd offers an email alert service to site visitors, in which we send subscribers email updates when new information is added to our site. If you decide to subscribe, you will be asked to provide basic contact information, such as your name and email address.
2. **Expressing an Interest in Working for WhizAnts Pty Ltd**

7. WhizAnts Pty Ltd Network

8. Sensitive Personal Data

- When explicitly requested by you, the site visitor; or
- As required by a court order or any other legal or regulatory requirement; or
- The disclosure is reasonably related to the sale or other disposition of all or part of our business.

Note: WhizAnts Pty Ltd does not collect or compile personal data or information obtained by this site for dissemination or sale to outside parties for consumer marketing purposes or host mailings on behalf of third parties.

10. Data Amendments and Retention
